### **Antioch College, Yellow Springs, OH**

Retained planned giving support is helping this iconic well-known undergraduate college find the resources to reopen.

### **The Center for Enriched Living, Riverwoods, IL**

Retained campaign counsel is underway to help The Center raise \$3 million to make capital improvements to its facility, establish an endowment fund and build a modest fund for innovative programs for the developmentally delayed children and young adults who are served by the Center. The campaign follows a feasibility study.

### **Edward Foundation, Naperville, IL**

A development audit led to a board self assessment that prepared this Chicago area hospital for a feasibility study that led to a successful \$3 million capital campaign for a new Cancer Center. Retained planned and major gift counsel is now being provided, and campaign counsel is being provided to raise major gifts for pediatric critical care programs.

### **National PTA, Chicago, IL & Washington, D.C.**

A collaborative national feasibility study has led to retained counsel to raise \$33 million over the next three years to let the National PTA relocate its headquarters from Chicago to the metropolitan Washington, D.C. area, establish a training and education center at the site and provide expanded program to bring parents closer to their children's education. National PTA is the nation's largest volunteer child advocacy association.
